South Staffordshire Playing Pitch Strategy and Action Plan

Addendum

June 2023

Background

South Staffordshire Council appointed Knight, Kavanagh & Page Ltd (KKP) to undertake a Playing Pitch Strategy and Action Plan which was published in September 2020.

The Strategy and Action Plan provides a clear, strategic framework for the maintenance and improvement of existing playing pitch and accompanying ancillary facilities up to 2037.

In line with the Playing Pitch Strategy Guidance (October 2013), the PPS should be reviewed on a regular basis to ensure that it remains up-to-date and relevant.

The Council engaged with the sports National Governing Bodies (NGB's) and other relevant stakeholders during late 2022 / early 2023 to seek any updates to the Strategy and Action Plan. These included: Sport England, Football Foundation, Staffordshire FA, England Hockey, England and Wales Cricket Board, Staffordshire Cricket, Rugby Football Union, Lawn Tennis Association, England Golf, British Crown Green Bowling Association and the internal South Staffordshire Council leisure services team. The Council consulted these sports NGB's and stakeholders again on a draft version of this addendum in May / June 2023 and their comments have been taken on board for this version.

Relevant section of the Action Plan has been updated and provided in appendix A to this addendum.

Factoring the differing sizes of facility in and normalising to 18 holes, this gives an equivalent number of 7.5 18 hole standard courses. Utilising this figure, the average sits at 490 which is still 20% above the national average.	
		Nationally, golf has increased in popularity and participation has been steadily growing since 2019. This initially is likely to have been a result of the lifting of restrictions and golf being one of the only activities allowed following COVID lockdowns, but this growth and interest has sustained despite all other sports and activities now being allowed. Sport England Active Lives data shows that participation during 21-22 was the highest it has been since 15-16 which was when data first started being collected.	
		So overall, whilst nothing needs to change in terms of the summary which recommends the current facility stock is retained, there is now potentially more pressure on the provision that is left to remain in place otherwise there is likely to be gap left between supply and demand.

In summary, several responses from stakeholders are factual in nature. These have been noted above and should be considered alongside the 2020 Playing Pitch Strategy and Action Plan.

Notable changes

<u>Chase Park</u>

Notable changes raised include the re-opening of Chase Park which is now being used for hockey and cricket. Chase Park remains an unsecure facility and several facilities require upgrading or improvements (see responses from Sport England and Staffordshire Cricket). The Action Plan entry for Chase Park has been updated (see appendix A). It will be important to monitor the changing situation at Chase Park and support the full re-opening and upgrading of facilities on the site wherever possible. This may include seeking funding for specific improvements.

Staffordshire FA

The Staffordshire FA have provided an update on the number of teams playing in the area. The data shows that there were 300 teams who were based and played in South Staffordshire in 2022/23. This is a large increase compared to 221 teams in 2020.

This level of increase in demand would result in additional demand for 3G and grass pitches within the district. The 2020 Playing Pitch Strategy and Action Plan does currently show spare capacity of grass pitches in some areas of the district. In addition, a 3G pitch has recently been delivered at Wombourne High School.

These figures will need to be kept under review going forward. The 2022/23 data set shows a large increase in the number of teams and corresponding demand for pitches. If this level of demand is maintained going forward, consideration will need to be given to providing additional pitches which will be reflected though an updated Playing Pitch Strategy and Action Plan.

Staffordshire Cricket

Staffordshire Cricket have highlighted significant growth in women's & girl's cricket in South Staffordshire within the last couple of years and provide a list of clubs which have a women/girls section. Similar to the increase in football teams, it will be important to monitor this area moving forward with any additional need being quantified and reflected though an updated Playing Pitch Strategy and Action Plan. The reopening of Chase Park (which includes 2 cricket squares) may help to absorb some of this increased demand.

Conclusion

In summary, it is concluded that the 2020 Playing Pitch Strategy and Action Plan still remains relevant when read in conjunction with the changes listed within this addendum. It will be important to monitor the situation regarding increased demand in football and cricket and moving forward. The Council will aim to review the Playing Pitch Strategy and Action Plan again in 12 months' time which will consider if a new updated Playing Pitch Strategy and Action Plan is required.
