LOCATION

Element Court is situated on Hilton Cross Business Park, Wolverhampton. Hilton Cross Business Park is a well-established and popular commercial area approximately 5 miles north of Wolverhampton City Centre.

The property benefits from excellent connections to the motorway transport system including the M54 (Junction 1), M6, M6 Toll and M5. The Business Park has direct access from the A460 Cannock Road (a primary route between Wolverhampton and Cannock) onto the M54.

SERVICES

A service charge is levied to cover the costs in services.




