

SOUTH STAFFORDSHIRE DISTRICT COUNCIL

TOWN AND COUNTRY PLANNING GENERAL DEVELOPMENT ORDER 1988

WHEREAS the Council of the District of South Staffordshire being the appropriate local planning authority within the meaning of Article 4 of the Town and Country Planning General Development Order 1988 are of the opinion that development of the description set out in the Schedule hereto should not be carried out on land and premises within the South Staffordshire District being the land and premises shown edged red on the plan annexed hereto unless permission therefore is granted on application made under the Town and Country Planning General Development Order 1988.

AND WHEREAS the Council are further of the opinion that development of the said description would be prejudicial to the proper planning of their area and would constitute a threat to the amenities of their area and that the provisions of paragraph 4 of Article 5 of the Town and Country Planning General Development Order 1988 should apply to this direction.

NOW THEREFORE the said Council in pursuance of the powers conferred upon them by the said Article 4 hereby direct that the permission granted by Article 3 of the Town and Country Planning General Development Order 1988 shall not apply to development on the said land or premises of the description set out in the Schedule hereto.

THIS DIRECTION is made in pursuance of the provisions of paragraph 4 of the said Article and shall remain in force until 10th December (being six months from the date of this direction) and will then expire unless it has been approved by the Secretary of State for the Environment before that date.

SCHEDULE

The holding of markets within the South Staffordshire District at Blacklees Farm, Saredon, as shown edged red on the plan attached hereto being development comprised within Part 4 Class B referred to in Schedule 2 of the said Order and not being development comprised within any other class.

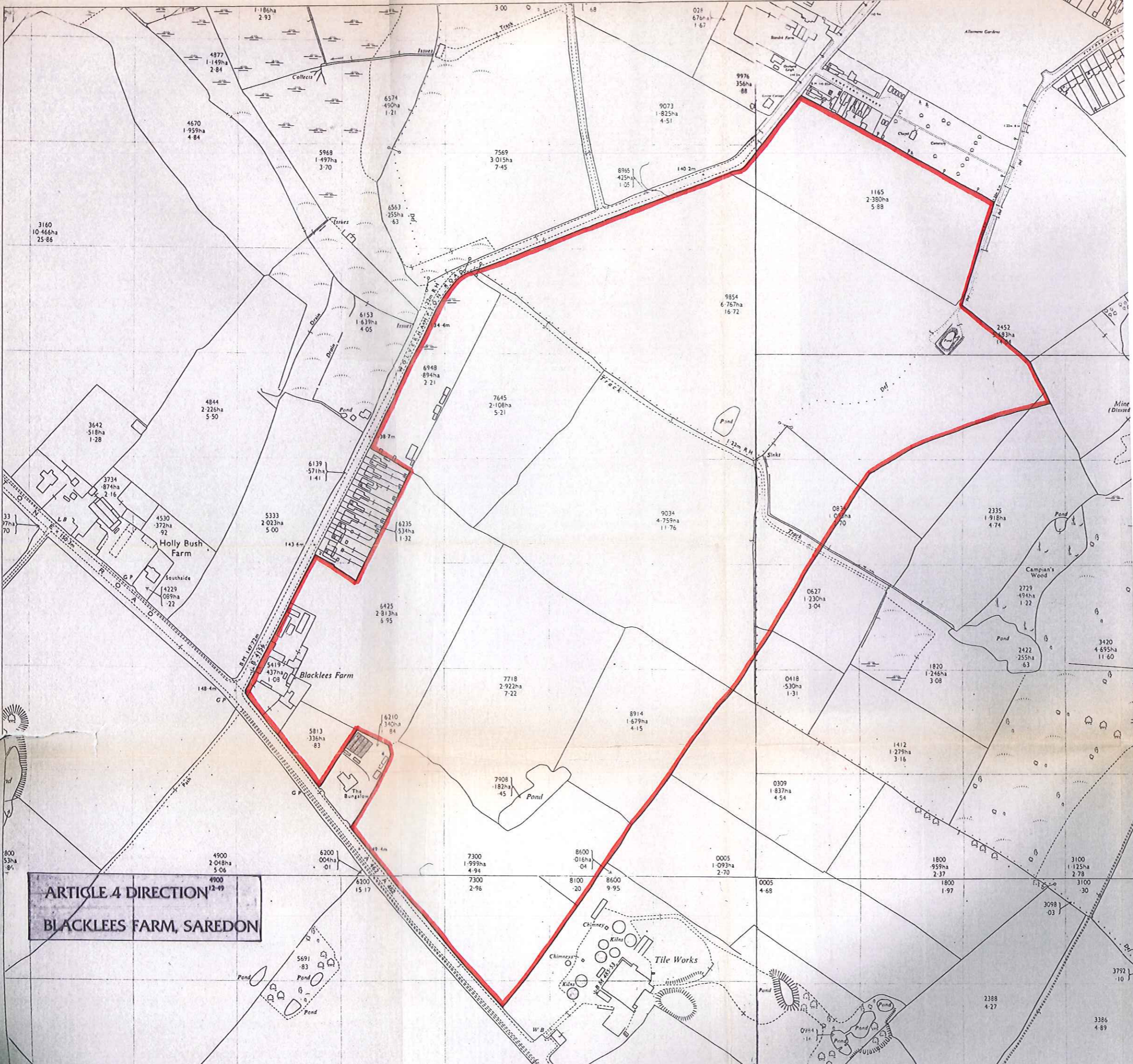
