

WOMBOURNE Sites 285 / 459 / 562/415

The road system is completely inadequate for this size of town.

Travelling from the west of Wombourne towards Sedgley & Wolverhampton requires travelling on a suburban road (Poolhouse/Ounsdale Road/School Road) which is not designed for such a high traffic flow. This links the northern route link between Smestow (CoPart Site) and A449 roundabout at Wodehouse NE Wombourne. Nor is it built to accommodate vehicles of more than 7.5t. There are two schools on this road which has a significant effect on the traffic flow, especially at school times. There is a petrol filling station adjacent to a Windmill Bank where cars wishing to refuel regularly back up on to the road. Having this section of the main road marked with a 'Keep Clear' notice is completely useless

The proposed new housing (Sites 285 / 459 / 562/41) is along this arterial road. If houses are then built this will only exacerbate the problem. Wombourne School Road by St Benedict's school is effectively a one carriage road and assuming parents insist on taking their children to school in cars and large 4x4's major congestion and will only get worse. Building on sites 463 & 284 will only exacerbate the problem. Similarly, Planks



Lane by the Wombourne village centre is effectively a one lane street and this is on the main bus route. Cars park here due to their being a lack of parking in the village centre.
