The Housing White Paper of Feb 2017 says can only build in the green-belt if all other options exhausted. This reflects what the original Act of Parliament says.

The Council's argument in favour of Green Belt construction over Open Countryside is perverse. Reading through policy DS2 it puts conditions on development.

"The Open Countryside contains many sensitive areas, including its landscapes and areas of ecological, historic, archaeological, agricultural and recreational value."

This applies equally to the Green Belt.

The policy lists a tiny number of exemptions to the effective policy of the council not to build in Open Countryside but to build in Green Belt (or to be pedantic, in land taken out of Green Belt)

Taking just a single example

- "A. A new or extended building, provided it is for:
- a) purposes directly related to agriculture or forestry; or "

Thses conditions are not being applied to the Green Belt, even though the chosen sites involve building on agricultural land.

The whole policy, starting from the Green Belt search for sites has an in-built bias in favour of building in the Green Belt (which is supposed to be the last resort) as opposed to Open Countryside.



This paragraph from the 'South Staffordshire Green Belt Review Final Report v3, appears to say there is a risk of building somewhere we are allowed to build, if we don't cram all of our development in the place we are only supposed to develop in as a last resort. 2.20 With 20% of the District's land not designated as Green Belt, the District is at risk from development 'leapfrogging' to sites immediately beyond the Green Belt boundary.
The original intention of the Green Belt act was to build in Open Countryside rather than Green Belt – to preserve a ring around the conurbation.
