5.61 The Black Country authorities are also preparing their Local Plan with the Black Country Draft Plan (August 2021) confirming that they have a need of 565ha of employment up until the end of their plan period (2039). The Black Country Draft Plan confirms they are only able to deliver 355ha of this, leaving a shortfall of 210ha. Their Draft Plan indicates that this unmet need should be exported, as far as possible, to authorities that have a strong existing or potential functional economic relationship with the Black Country; to be agreed through a Statement of Common Ground.

The Black Country have scrapped the Black Country Plan, therefore the numbers quoted here are completely meaningless and cannot be relied upon as a factual basis upon which to calculate South Staffordshire's plan. These are now nothing better than made up numbers. There has also been significant press criticism that the Black Country has wasted £2million of taxpayers money on the now scrapped Black Country Plan, therefore it cannot be ruled out that South Staffordshire are pushing their plan through despite the wishes of residents in order to avoid similar embarrassment. Frankly the wishes and the needs of the people who live here far outstrip South Staffordshire Councils reputation or wish to not be criticized in the press.

- 3) To delay the local plan until the passing of the Levelling Up Bill currently going through parliament, which amongst other things adds a duty to adopt an infrastructure first approach to development. This plan asserts that 500+ homes can be added to Wombourne, the largest of any area despite being a tier 2 village. No Tier 1 village has such a large contribution, yet by its own definition a Tier 2 village does not have the resources and accessibility of a tier 1 village. There is not a single road, doctor, nurse, teacher or police officer accounted for in this plan to service the needs of a population that already cannot access services, already has congestion issue, has no rail station, no road connection to a major transit route, and has no large employment base which would negate the need to commute to/from the area in order to be able to afford to live there.
- 4) Reduce Wombourne's contribution to below 100 houses and place them on brownfield sites. The 'exceptional circumstances' necessary to justify destroying green belt land does not include the failure of SS planning dept to effectively identify and secure brownfield site.
