In respect of Wombourne the plans are unsound.

The information presented re employment data is far too confusing and jargon based for people outside of a planning department to understand. However looking at the table, there are three employment sites identified in Wombourne, for which only 1Ha is available for employment development. I read this as next to no opportunity for employment development for an area that is due to take 500 extra houses. Where will all these people work?

Of course they will commute outside of Wombourne in order to earn enough money to be able to afford to live there, like the vast majority of working residents do. But there are no rail links. The bus services are not commuter based, there are no links to mass transit road networks. The motorways and main arterial routes are miles away and accessible mainly through single carriageway roads prone to choking up with traffic.

The plan is completely unsound in respect of Wombourne, it has been written off to receive an undue number of houses with no infrastructure and no investment in the area to support such a population increase. Read the plan from pages 60 to 76 and read the detailed considerations other localities have been given, in respect of social, economic and environmental considerations. Wombourne has NONE of this in this plan, but an enormous amount of houses, 100% built on the green belt.

- 1) To add a democratic vote of residents before approving any green belt site for development
- 2) To delay the local plan until the duty to co-operate issue is resolved, i.e is it being abolished, and how can we co operate with neighbours who have scrapped their own plans
- 3) To delay the local plan until the passing of the Levelling Up Bill currently going through parliament, which amongst other things adds a duty to adopt an infrastructure first approach to development. This plan asserts that 500+ homes can be added to Wombourne, the largest of any area despite being a tier 2 village. No Tier 1 village has such a large contribution, yet by its own definition a Tier 2 village does not have the resources and accessibility of a tier 1 village. There is not a single road, doctor, nurse, teacher or police officer accounted for in this plan to service the needs of a population that already cannot access services, already has congestion issue, has no rail station, no road connection to a major transit route, and has no large employment base which would negate the need to commute to/from the area in order to be able to afford to live there.
- 4) Reduce Wombourne's contribution to below 100 houses and place them on brownfield sites. The 'exceptional circumstances' necessary to justify destroying green belt land does not include the failure of SS planning dept to effectively identify and secure brownfield site.
- 5) Produce a proper economic and employment strategy bespoke for Wombourne.
