EC12: Sustainable transport The council will work proactively with partners to promote sustainable transport measures and deliver high quality transport infrastructure and links across the district. This includes opportunities to improve bus and rail services and connections including making provision from increased demand from new development within the district.

In respect of Wombourne the plans are unsound.

None of the above applies to Wombourne, there are no improvements to bus services and there is no rail service. There are no links across the district, Wombournes two bus routes will only take you to Wolverhampton and Merry Hill/Stourbridge, both of which are in the West Midlands.

All new developments will be required to demonstrate all of the following: a) Designed to maximise opportunities for walking, cycling and the use of public transport, ensure the safe movement of vehicles and minimise the impact of parked and moving vehicles on residents, business and the environment. Developments should adhere to the standards set out within LTN 120 or subsequent additions.

There is not a single improvement to infrastructure to support the addition of 500 houses to Wombourne.

-Road infrastructure on Poolhouse Road. How will additional entrances junctions add to the build of traffic on this road? b) Safe access and an acceptable degree of impact on the local highway network.

c) Provision of safe, direct routes within permeable layouts that facilitate and encourage short distance trips by walking and cycling between home and nearby centres of attraction, and to bus stops or railway stations, to provide real travel choice for some or all of the journey. Travel routes should link into existing travel networks beyond the development site where possible. The long-term management of the public realm including transport infrastructure must be ensured.

Train Links and Public Transport- Wombourne has no train station, with the nearest train station being Coseley, around 20-25 minutes drive away, longer during commute times. It has two bus routes, servicing only Wolverhampton and Merry Hill/Stourbridge. There is a significant drive until any of the main arterial routes can be driven to, such as the M6, the Black Country Route, or the M5.

There is no 'travel choice' for the residents of Wombourne, which is well known as a commuters village. You would know this if the planning officers had actually bothered to learn about Wombourne before trying to destroy it. You can see this every morning when everyone of working age gets in their cars to go to work. The entrances and exits to the village choke up with traffic during rush hours as it is. If for instance, you work in Birmingham, you have to drive through Wombourne, adding to its traffic, cross the roundabout onto Wodehouse Lane, which is single carriageway all the way to Sedgley. Cross through Sedgeleys town centre, which is congested, then through Woodsetton, again single carriageway, then cross the Birmingham New Road, a busy main arterial route, to get to Coseley train station. This journey is 20-25 minutes in clear traffic, due to the amount of stopping at junctions and traffic lights, and Sedgley's town centre. Coseley station has around 3 trains an hour, one of which passes through without stopping. This will take you to Birmingham New Street where you again have to change trains to get to anywhere else.

d) Protection of existing rights of way, cycling and equestrian routes (including both designated and non-designated routes and, where there is evidence of regular public usage, informal provision). If it is demonstrated that the loss of such as route is unavoidable, the development should provide suitable, more appealing or at least equal replacement routes.

Wombourne has several well-loved walking routes, many of which include the fields by Billy Buns Lane, which leads to Ladywell Woods. This will be destroyed by the plan. Access is via a gate on Billy Bunns Lane. This leads up to fields with horses and cows, which are well loved by the local children. The planners do not care about this, only meeting their made up housing target.

e) Adequate provision to mitigate the likely impacts (including cumulative impacts) of their proposal including environmental impacts (such as noise and pollution) and impact on amenity and health. This will be achieved through direct improvements and Section 106 contributions.

500 houses means around 1000 extra cars. This will obviously add to noise pollution, light pollution (through additional street lighting which is not currently required but would be on the roads due to have sites attached to them) and air pollution. No air pollution survey has been conducted in any form as far as I am aware, and when I asked about it at the previous consultation I did not get a straight answer. In addition, it has not been stated where the waste from these 500 houses will be processed, it must be assumed the waste management site on the Heath Mill estate. This estate created a powerful odour in summer months as it is, no assessment has been put forward as far as I am aware as to the impact the additional houses and their waste will have. Finally, the recycling centre will not operate with such a large population increase.



- 6.  - Add a proper infrastructure delivery plan to Wombourne BEFORE a single house is built, to include, new schools, new doctors surgeries and an NHS commitment to staff them, a road network plan available for residents and the highways agencies to critique prior to implementation, a permanent police station. Public electric car charging points (there are none currently)
 - 2) To add a democratic vote of residents before approving any green belt site for development
 - 3) To delay the local plan until the duty to co-operate issue is resolved, i.e is it being abolished, and how can we co operate with neighbours who have scrapped their own plans
 - 4) To delay the local plan until the passing of the Levelling Up Bill currently going through parliament, which amongst other things adds a duty to adopt an infrastructure first approach to development. This plan asserts that 500+ homes can be added to Wombourne, the largest of any area despite being a tier 2 village. No Tier 1 village has such a large contribution, yet by its own definition a Tier 2 village does not have the resources and accessibility of a tier 1 village. There is not a single road, doctor, nurse, teacher or police officer accounted for in this plan to service the needs of a population that already cannot access services, already has congestion issue, has no rail station, no road connection to a major transit route, and has no large employment base which would negate the need to commute to/from the area in order to be able to afford to live there.
 - 5) Reduce Wombourne's contribution to below 100 houses and place them on brownfield sites. The 'exceptional circumstances' necessary to justify destroying green belt land does not include the failure of SS planning dept to effectively identify and secure brownfield site.
 - 6) Conduct actual air quality surveys, noise and light polition surveys, traffic surverys and demonstrate to local people how this is meant to be beneficial to them


