The plan fails to reflect the statement by the Secretary of State for Levelling UP, Housing and Communities and Minister for Intergovernmental Relations made to the House of Commons 6 December 2022 Statement UIN HCWS415. Notably:

'Where authorities are well-advanced in producing a new plan, but the constraints which I have outlined mean that the amount of land to be released needs to be reassessed, I will give those places a two year period to revise their plan against the changes we propose and to get it adopted. And while they are doing this, we will also make sure that these places are less at risk from speculative development, by reducing the amount of land which they need to show is available on a rolling basis (from the current \square ve years to four).'

Further, in respect of the previously mandated figure for new houses, which the Plan has proposed to meet with the late addition of the previously excluded land on map 036c, it states:

'This number should, however, be an advisory starting point, a guide that is not mandatory. It will be up to local authorities, working with their communities, to determine how many homes can actually be built, taking into account what should be protected in each area - be that our precious Green Belt or national parks, the character or an area, or heritage assets. It will also be up to them to increase the proportion of affordable housing if they wish.'



I believe it is evident from this Statement that the present plan should be withheld, revised and re-submitted for a full and open public consultation, this time in compliance with the revised requirements from the Secretary of State.
