With regards to Policies map, I have come to the view that site 036c fails all 3. It is my considered opinion that the site of 036c in the South Staffordshire Publication Plan, The Plan, is unsound and may not be legally compliant. From information gained via local Councillors, it has not been the subject of 'effective duty to co-operate' liaison with Stafford Borough Council. In view of this I ask that site 036c be deleted in its from the Plan. My reasons are its questionable legal Compliance. The use of site 036c fails the National Planning Policy Framework 19 December 2023 <https://www.gov.uk/guidance/national-planning-polict-framework> Section 15 Conserving and Enhancing the natural environment. Compliance with the NPPF is a legal obligation.

A The land is productive farmland classified by SSDS consultant Lepus in their report Regulation 19_SA Report October 2022 LC-829_Vol_2of3_Reg19_SA_South Staffs_20_121022.B.docx in Fig 14 as grade 3 but transitioning to grade 2 towards the Village of Acton Trussell. I understand from the tenant farmer (Parrot family) that the land is very productive, it is grade 3.

B It is classic rolling countryside providing an excellent vista from the large Wilwood (Stafford) development and the A34 SE of Stafford.

C The site 036c is noted for its diversity of wildlife. It has recorded 34 species of birds which are seen on a regular basis. These together with deer, badgers, bats and hares. It is an important corridor link with wildlife and biodiversity connecting Cannock Chase AONB and the Staff and Worcester Canal, the River Penk and its flood plains to the West. This connectivity is established as important in the Staffordshire Wildlife Trust Biodiversity Report; it appears to have been ignored in the Plan in respect of site 36c.
