THE NOISE LEVEL THAN EXCEEDED THESE RECOMMENDATIONS. SINCE THEN THE M6 HAS BEEN WIDENED TO 3 LANES AND TRAFFIC FLOWS HAVE INCREASED GREATLY, INCREASING NOISE POLLUTION ACCORDINGLY.
