Quote: Sensitive developments such as housing will not be permitted in the vicinity of established sources of pollution which may give rise to harm to the amenity of occupants.

There is a source of pollution in the area. The local brickworks were converted into a tip after closure, then when that was closed, illegal tipping carried on for some time before any action was taken to stop this activity. The tip has subsequently been capped and is deemed 'safe' but since it may contain toxic waste new residents should be warned of the potential danger
