I consider that, in respect of site 036c in the South Staffs Publication Plan, the Plan is unsound and may not be legally compliant. It has evidently not been the subject of effective 'duty to co-operate' liaison with Stafford Borough Council (SBC).
I ask for site 036c to be deleted, in its entirety, from the Plan.

Quote: Proposals that do not provide contributions towards education infrastructure where it has been determined that these are necessary will be refused.

Reading the county council education department response, it would appear that their only solution is to take money from the developers, as stated above, but since all the nearby schools are fully committed the money taken will be used to transport students several miles each day to an available establishment. This fails on two counts – ability of students to walk to their establishment and adding to the increased traffic congestion in the area.
