**There appears to be some concern about flooding on the River Penk at Penkridge.**

**No mitigation is mentioned for the consequences of flooding in Stafford where the Penk and Sow converge.**

**There is no mention with regards to 036C that the possibility of fluvial flooding of Hazlestrine Lane when the land currently capable of absorbing rainwater is covered with dwellings and infrastructure. Thus, flooding may well occur and lead to subsidence of garden properties abutting the lane.**
