I consider that, in respect of site 036c in the South Staffs Publication Plan, the Plan is unsound and may not be legally compliant. It has evidently not been the subject of effective Infrastructure Delivery Plan

I ask for site 036c to be deleted, in its entirety, from the Plan.

My reasons are:

- a) The current infrastructure is overloaded. Schools are full with current level of housing, together with waits of at least 3 weeks for a doctor's appointment. There is no Accident and Emergency cover overnight at the local hospital.
- b) The proposed site 036C is situated alongside a very narrow road, just a country lane without footpaths, which is currently used as a rat run through to the M6 via Acton Trussell. Traffic here increased considerably after the previous housing estate was built on the A34 at Wildwood. It is only a matter of time before there are accidents on the route through to the M6 & West Midlands.
