We consider that, in respect of site 036c in the South Staffs Publication Plan, the Plan is unsound and may not be legally compliant.

Our reasons are:

The use of site 036c fails Policy HC15: Education in the South Staffs Publication Plan Page 100.

HC15 states:

"Proposals that do not provide contributions towards education infrastructure where it has been determined that these are necessary will be refused."

SSDC does not have local Education provision for this development. The nearest Schools are in Stafford Borough and are oversubscribed.

According to Policy HC15 it would appear that this development must be refused.

Stafford Borough Local Plan 2020-2040 page 95 Policy 37 'Infrastructure to support new development' states:

A new development that generates a demand for infrastructure will only be permitted if the necessary on and off-site infrastructure required to support and mitigate the impact of that development is either:



- 1. Already in place; or,
- 2. There is a reliable mechanism to ensure that it will be delivered in the most appropriate place, to the required standard and when required.

Our advice from Acton Trussell, Bednall and Teddesley Hay Parish Council is that the residents of Wildwood have significant concerns regarding the ability of local schools (and health facilities) to cater for the increased demand.

Quoting from information provided by ATBTH Parish Council:

"In respect of schools the publicly available data (as at 23.05.24) shows that all the closest schools are full:

Oak ridge oversubscribed by 9(219/210) Walton High oversubscribed by 1(211/210) Leasowes Primary oversubscribed by 8 (428/420)

The Council's Housing Selection Topic Paper at Section 5.27 asserts at para. 5.27.5 that the proposal has been assessed as "having major positive impacts against education" based only upon the "site's proximity to local schools".

Stafford Borough Council's response in the 2022 consultation to the identical proposed housing allocation on its border considered that the proposed did ".. not demonstrate it would provide appropriate infrastructure to mitigate the impact. There is no relationship to the existing urban form. The site is remote from any settlement or services in South Staffordshire, with the occupiers of the development looking to Stafford Town to provide their services. Accordingly this will impact on schools and leisure provision in Stafford, which have a number of capacity issues." It also refers to evidence at the time (and still understood to be the case as above) that "this area of Stafford Town - south is not able to accommodate further school provision."

There is no stipulation associated with 036c that requires the construction of new school facilities in this locality within South Staffs, the proposal refers only to dwellings. The mechanism referred to in Stafford Borough Local Plan 2020-2040 page 95 Policy 37 appears not to exist making the proposal for site 036c at odds with the policy of Stafford Borough.

Our understanding from our Parish Council is that Stafford Borough are opposed to this development on their southern border as set out in our previous Part B objection under Policy DS5 Spatial Strategy.

"The Plan for Stafford Borough is based on the clear conclusion that development in this location is both less practical and less sustainable than at other locations around Stafford town, and it is therefore not proposed to identify significant development south of Stafford in the new Plan. This expressed joint conclusion has not been taken into account in the South Staffs Publication Plan."

In respect of site 036c in the South Staffs Publication Plan, we consider the Plan to be unsound and failing in its legal 'duty to co-operate' (SSPP 2020-2040 page 11 para.3.6).
