The Cannock Chase AONB is recognised as a highly sensitive area where visitor management is critical to maintaining its characteristics. With already planned increasing housing development in the wider vicinity and the growing human population, recreational use is predicted to increase.						
It is further acknowledged by the bodies responsible that there is a need to meet recreation demand while, in the long term, ensuring that the issues associated with high levels of recreation do not cause damage or lessen the experience for others.						
To identify a new housing site so close to the AONB is at odds with the need for its conservation, particularly where there is no overriding need for the site proposal.						
HC17 advises that the NPPF requires that existing open spaces should be protected.
