In respect of Policy EC4 I think the inclusion of site 036c in the LP makes it not sound. Policy EC4 at 4.4 states "*The development will not cause significant or unacceptable harm to the character and appearance of the landscape and avoids the loss of large areas of higher quality agricultural land.*" I have lived in the locality of proposed site 036c for 27 years and I'm familiar with how the land is farmed. The crop is rotated, currently the land is growing barley but in past years has grown wheat, potatoes, oil seed rape and grass pasture for livestock. The land is therefore versatile and fertile which is the definition of "higher quality agricultural land." The inclusion of site 036c in the LP contravenes Policy EC4.
