I consider that this part (005) of the Local Plan is unsound.

The local roads on the Cherrybrook Estate in Penkridge do not provide effective means of access for increased volumes of road traffic. This is in terms of the vehicles of residents of any potential new housing, any construction traffic, waste removal or blue light vehicles. The roads are too narrow and especially the potential connection road to any new build properties. There would also be much increased congestion to the single Cannock Road T junction at peak times.

There would be much noise and carbon exhaust pollution from the nearby M6 motorway. The latter has enormous traffic volumes. The M6 is only 100 -200 metres away. There would not be an effective duty of care for residents.

There are issues related to surface water drainage on the proposed building plots. The local canal is a short distance from the proposed building plot. There are already sewerage problems on Cherrybrook Estate.

Cannock Chase is less than 3 miles away. It is an area of Outstanding Natural Beauty.

There are bats which are present locally and roost. These should not be disturbed.

This 005 part of the Local Plan should be removed.
