

Housing growth will be located at the strategic allocation MADE ADJACENT to Stafford through this Local Plan, in order to FACILITATE SUSTAINABLE GROWTH at a non- Green Belt location This is :
Land at Weeping Cross, west of the A34
1) This is in DIRECT CONTRADICTION of Clause 5.28 which said the location will not be the focus for larger scale growth .
2) What SUSTAINABLE GROWTH is envisaged that does NOT affect THE SENSITIVE LANDSCAPE and POTENTIAL HIGHWAY CONCERNS in Clause 5.28 ?
3) Clause 5.28 describes the location as AN EXTENSION to the adjacent town of Stafford – now it is ONLY ADJACENT to the town of Stafford



This is clearly poorly thought out Open Countryside Policy DS43 and Spatial Strategy DS5 – they are mutually contradictory .

Fact – Weeping Cross is East of the A34 and is also East of the A513 , it is totally impossible for Weeping Cross to be West of the A34
