We object to the employment land levels in the plan. Our objections relate to Para 5.61, Policy DS4, as well as, by extension, to SA1, SA2, SA3, SA5 and SA7.

To support our objection, we attach the relevant capacity reports we did on the Black Country [Black Country Plan brownfield study, with its appendix Black Country Urban capacity update] and Birmingham [Birmingham Plan Issues and Options 2022], and these should be read alongside this objection.

We object to the level of employment provision, and in particular the allocation of 36.6 hectare for needs in the Black Country as set out in Para 5.61 and DS4

The Black Country Urban Capacity Report did refer to a shortfall of Industrial Land, which it puts at 553 hectares. However, the updated Economic Development Needs Assessment (published in August 2021) gave figures for industrial land varying from 364-502 based on past completions and 418-806 based on GVA assumptions. There is little need under their Employment based Scenario for any additional land.

Clearly the resulting plan figure is a matter of judgment and could have been subject to objection at Regulation 19 Stage and further testing had that gone ahead.

And even if one accepts, according to ABCA, a shortfall of 210 hectares we are not convinced that only 30-35% of the proposed 270-hectare West Midlands Interchange Site (80-100 hectares) should be considered as meeting Black Country need.

The Black Country Plan is not now going ahead and the individual plans are at an embryonic stage and will not be submitted to the Secretary for some time. It is unclear what obligation South Staffordshire will be to meet employment need if it arises or what level of need there will be, given structural changes to the economy.
