Sport England considers that Policy HC18 is not consistent with national planning policy namely NPPF paragraph 99 due to the following reasons: 1. NPPF paragraph 99 relates to the protection of Playing Field Land which can be marked out for a variety of pitch types and sizes. The pitch layout of a site can ultimately change over time to meet demand or capable of meeting future demand identified within a needs assessment for playing pitches.

As currently worded Policy HC18 it could be perceived that it relates to a playing pitch marked out at a point in time and it does not consider the wider playing field site and its ability to accommodate pitches. This could lead to a situation whereby a site which was previously marked out for a number of pitches but at the point of an application being submitted no pitches are marked out, as such the proposal would not be assessed against Policy HC18. Sport England are sure this is not intention of the policy and as such would wish to see the policy revised in line with NPPF paragraph 99 as included within Policy HC17 Open Spaces.

2. Criterion a states that engagement should be had with Sport England in relation to the assessment, whilst this welcomed it might not be serviceable. As such it is recommended that reference to supporting text to the policy should highlight that the applicant is encouraged to undertake an assessment in line with Sport England's needs assessment guidance for playing pitches and sports facilities.

2. Criterion b solely relates to the replacement provision being of at least equivalent quality but omits quantity as per NPPF paragraph 99b. 3. A further omission of the policy is the exclusion of paragraph 99c which is catered for within Policy HC17
