Paragraph 11.7 The Council will continue to work with the Airport owners and operators to deliver a sustainable future for the airport, **through the preparation and development of an Airport Master Plan**. The replacement of obsolete wartime buildings with new high quality development will generally be supported, subject to being consistent with other Local Plan policies. The existing non-aviation uses on the site are accepted, but the overall aim is that existing buildings **and the site generally** should be used for aviation uses related to the general aviation role of the airport.
