Policy HC19: Green Infrastructure We welcome the support for green infrastructure laid out in this policy, but feel that this could be strengthened and made more specific. We note there is no mention of Local Green Spaces anywhere the Plan. While the Local Green Spaces Topic Paper 2024 presents a useful overview of legislation, we feel it fail clarify the special and complementary nature of LGS designation compared to other protections: Based on value to local people: LGS is the only protection which takes account of the value local people attach to a site. Specific to location: LGS is the only protection which is truly site-specific. (Green Belt sites are assessed only against the purposes of Green Belt, such as separating towns, making it possible to argument an individual parcel is not very important. Wildlife and sports/amenity sites can be set aside if, in udgement of the planning authority, similar habitats or amenities are available nearby). This is clearly a missed opportunity, and policy enhancement should be linked to Biodiversity Net Gain projects.	s to I ue the
