Sport England welcomes a number of changes to the policy and its supporting text from that previously set out in the November 2022 consultation document.							
Sport England would request that a further amendment is made to the title of the policy by replacing pitches to fields. This would remove any ambiguity as to the remit in that it seeks to protect playing fields and not pitches marked out at a particular point in time thus making the policy more effective.							
Sport England welcomes development or improvement of new playing fields and sports facilities will be supported in accordance with the latest Sport Facilities and Playing Pitch Strategies. However, Sport England also considers that other proposals could come forward outside of the above mentioned strategies which could support increased sporting participation and physical activity benefiting the health of wellbeing of residents. This should be acknowledged within the policy or the supporting text. It should also be noted that the Council's strategies should e kept up to date.
